## APPLYING FOR A RESIDENCE PERMIT AUTHORISING YOU TO START A BUSINESS OR SEEK EMPLOYMENT



A foreign student who has just obtained a French diploma at least equivalent to the master's degree, a professional license, a Master's degree or a Master of Science issued by a member institution of the Conference of Grandes Écoles (CGE) may stay in France at the end of his/her studies to look for a job or create a business, by applying for a temporary residence card « job search/ business creation » (RECE – Recherche d'emploi Création d'entreprise) valid for one year (law of 10 September 2018).

Students from countries that have bilateral agreements with France can apply for a **provisional residence permit** (« autorisation provisoire de séjour » or APS) for the same reason. The duration of the APS and conditions for the delivery will depend on the agreement.

Students of Algerian nationality do not benefit from this option.

## **PROCEDURE**

Students living in Paris (75) must submit their application online at the following address: https://www.demarches-simplifiees.fr/commencer/prefecture-de-police-de-paris-ressortissants-etran

The following documents must be submitted (PDF only):

- "student" residence permit or visa + confirmation of online validation of the visa;
- passport (pages related to marital status and validity dates);
- recent passport photograph up to current standards;
- proof of your health insurance;
- residence permit application form of the Police Prefecture
- proof of address less than 6 months old:
  - if tenant: electricity bill (or gas, water, landline telephone or Internet service bill) or rental lease agreement less than 6 months old or rent receipt or housing tax statement;
  - if staying at a hotel: hotelier's certificate and bill;
  - if staying with an individual: dated and signed statement from the host, copy of his/her identity card or residence card, deed of ownership (or the host's statement of residence tax or copy of the rental lease agreement or the host's electricity, gas, water, landline telephone or Internet service bill);
- diploma obtained within the last twelve months or certificate of successful completion issued by the examination board:
  - diploma at least equivalent to a master's degree;
  - professional diploma;
  - Level I diploma certified by the Conférence des Grandes Écoles (master's degree and "master of science" degree).

If the application is complete the student is notified of an appointment for the submission of a paper copy (picture on phone not accepted) of each document he/she uploaded and receives a  $r\acute{e}c\acute{e}piss\acute{e}$ , then is informed by text message (sms) as soon as his/her residence card is available. On the day of the card's collection, the student must pay a fee of  $\in$  75 in the form of a tax stamp.

In the case of bilateral agreement students do not have to pay any tax to obtain their APS.







## **RIGHT TO WORK**

During the validity period of the residence permit for seeking employment / starting a business, the holder is authorised to seek and perform a job related to his/her training or research, with a salary of more than 1.5 times the monthly SMIC (French minimum wage), which is € 2,620.80 as for a monthly gross salary

Before the expiry date of RECE card, the young graduate holding a Job Search business creation card will have to apply for a change of status according to his/her situation.

In the case of salaried employment, s/he may, in particular, apply for one of the following residence permits:

- From a monthly gross salary of € 2,620.80 and if the job is related to the education received, he/she will be allowed to apply for a « travailleur temporaire » or a « salarié » residence card without the employment situation being invoked against him/her.
- If he/she has obtained a work contract longer than 3 months with a monthly gross salary of at least € 41,933, he/she will be allowed to apply for a « Passeport Talent salarié qualifié » or « passeport talent entreprise innovante » residence permit.
- From a monthly gross salary of € 53,836.50 €, he/she will be allowed to apply for the residence card
  Passeport talent carte bleue européenne ».

For starting a business, he/she may apply for a temporary residence card for business owners / professionals « entrepreneur/profession libérale » or a multi-year passeport talent residence card for starting a business « passeport talent création d'entreprise ».

Under certain conditions, he may apply for a multiannual residence card for a **passeport talent – chercheur** » (researcher ) or for a **passeport talent - profession artistique et culturelle** »

Beware: for Passeport Talent residence cards, applications must be submitted online 4 months at the earliest and 2 months at the latest before the expiry date of the RECE (or student residence card):

Beware: in case of delay, a penalty of 180 euros will be applied and will be added to the tax of the requested residence permit.
